

# **SOS Program Contract**

- 1. Zero tolerance from any alcohol/drug use. Any use will result in immediate discharge. If a client relapses, they will be required to go to residential treatment to be allowed re-admission into the house.**
- 2. Random U/A and breathalyzer's will be conducted.**
- 3. No Medical assisted treatment, this includes suboxone, methadone, and medical marijuana. Any prescription medications must be shared with and approved by staff.**
- 4. Releases of information for Probation officers, county workers, doctors, outpatient treatment, and mental health facilities must be signed when applicable.**
- 5. Zero tolerance for physical altercations or threats of violence.**
- 6. Curfew is 10:00 Sunday through Thursday and 11:00 Friday and Saturday unless authorized by staff.**
- 7. No intimate relationships unless they are married.**
- 8. Mandatory House meeting 1 night er week, this will be a 12 Step/Bible Study.**
- 9. Minimum of 3 AA/NA meetings each week. One Bible study may replace an AA meeting. Celebrate Recovery is considered an AA meeting. Client must have a sponsor and meet with that sponsor at least 30 days after admission.**

**10. Jobs/volunteer work is mandatory**

**11. Recovery workshops/conferences are strongly encouraged whenever applicable.**

**12. Each client will meet with staff for individual session each week to discuss needs and progress.**

**13. Minimum of 6 months stay with a maximum of 1 year unless otherwise determined by staff.**

**14. Client vehicles are allowed with a valid Minnesota drivers license, current registration, and insurance.**

**15. No gambling including lottery tickets and scratch-offs.**

**16. Visitors, including children, are allowed in the house with staff approval. No visitors in bedrooms.**

**17. Household chores will be shared by clients. Dishes must be washed immediately following use, no exceptions.**

**18. No smoking or vaping in the house. Violations may result in discharge.**

**19. This is not a rental agreement, and all fees are strictly for services provided. Rent is \$575.00 per month for double room and \$625.00 per month for single room. There will be a one-time cleaning fee to be paid at time of admission.**

**20. SOS reserves the right to terminate this agreement for failure to comply with the policies and procedures laid out within this agreement. Any items left at the house following discharge for any reason will be stored for 30 days. If arrangements have not been made to pick them up they will be given away or destroyed.**

**I have read and understand these guidelines and agree to abide by them for the duration of my stay at Matthews Corner.**
